## Instructions:

Thank you for your interest in my services. For our initial consultation I will need to see the following:

1. Your most recently filed income tax return. (Both business and personal if you own a business.)
2. A recent pay check stub for both you and your spouse. (Even if you are not planning to file jointly.)
3. A breakdown of any other income you have received in the last six months from sources other than employment.
4. A list of your creditors both secured and unsecured and the approximate amount you owe them.
5. If you can, pull a credit report at [www.annualcreditreport.com](http://www.annualcreditreport.com) and bring it with you.
6. Complete the *CLIENT INTAKE SHEET* on pages 2-4 and sign agreement on page 5.
7. I charge a \$50.00 consultation fee which is credited toward the full retainer of \$300.00. The retainer fee is due at the end of the consultation if you decide to move forward using my office. If you decide to explore other options, only the \$50.00 is due. I accept cash, check or money order payments, but no credit cards (it is a conflict of interest).

Once my office is retained, you will refer your creditors to me. Then under the Fair Debt Collection Practices Act, third party debt collectors must not communicate with you directly. They may only inquire about you through me, your lawyer.

My fee includes credit rehabilitation and can be paid over time. The credit rehabilitation process usually takes about a year, and is very important if you plan to purchase a new car or home over the next ten years. Credit repair is included at no additional cost and begins upon entry of the Bankruptcy Discharge Order. The process involves helping you audit credit reports and dispute negative items, as well as coaching you through several strategies designed to create positive relationships with new banks.
